Date of Commencement

ENACTED by the House of Assembly of Benue State of Nigeria as follows;

1. This law may be cited as the Capital Expenditure LAW 2021 and shall be deemed to have come into force on 1st January, 2021.

Title and Commencement

2. 1.The Accountant-General may, when authorized by warrant under the hand of the Governor, issue from the Consolidated Revenue Fund of the State, during the year ending the 31st December, 2021, any sum not exceeding in the aggregate [Forty Two Billion, Seven Hundred and Eighty-One Million, Eighty Nine Thousand, Five Hundred and Sixty One Naira](N42, 781,089,561)only as Capital Expenditure.

Capital Expenditure №42, 781,089,561

Restriction of withdrawal from Consolidated Revenue Fund

- 2. The sum specified above shall be appropriated to the Heads of Expenditure as set out in the SCHEDULE to this law.
- 3. No amount set out or part thereof shall be withdrawn from the Consolidated Revenue Fund after the 31st December, 2021.
