Date of Commencement

ENACTED by the House of Assembly of Benue State of Nigeria as follows;

- 1. This law may be cited as the Recurrent Expenditure LAW2021 and shall be deemed to have come into force on 1st January, 2021.
- 2. [1]The Accountant-General may, when authorized by warrant under the hand of the Governor, source income for the Consolidated Revenue Fund of the State, during the year ending the 31st December, 2020, any sum not exceeding in the aggregate \$\text{M91,593,676,750}\$ [Ninety-One Billion, Five Hundred and Ninety-Three Million, Six Hundred and Seventy Six Thousand, Seven Hundred and Fifty Naira] only.
 - [2] The sum specified above shall be generated from the sources set for the

Recurrent Expenditure of ¥91, 593,676,750

SCHEDULE to this Law as Revenue for the State.

[3] The sum specified in sub-section (1) above shall be appropriated for the services set forth in PART B of the SCHEDULE to this Law.

- 3. All Allowances Approved in the Estimates, except travelling allowances, shall be paid to the beneficiary through salary on monthly basis.
- 4. No amount set out in the schedule to this Law or part thereof shall be withdrawn from the Consolidated Revenue Fund after the 31st December, 2021.
